



## Limited Warranty – By-Pass Filter Systems

(for the 50 United States, the District of Columbia and Canada)

### WHAT THIS WARRANTY COVERS:

AMSOIL INC. of Superior, Wisconsin ("AMSOIL" or "AMSOIL INC.") hereby warrants all parts and components (except filters) of each AMSOIL By-Pass Filter System ("By-Pass System"), when properly installed and maintained, to be free from defect in material and workmanship. The following components are guaranteed for a period of 5 years from the date of original purchase of the By-Pass System directly from AMSOIL (e.g., by AMSOIL Dealer for resale or by Consumer directly from AMSOIL):

- filter mount assembly
- adapter fittings
- mounting brackets

The following components are guaranteed for a period of 3 years from the date of original purchase of the By-Pass System directly from AMSOIL:

- hose
- fittings
- gaskets
- fasteners

### WHAT THIS LIMITED WARRANTY DOES NOT COVER:

- AMSOIL By-Pass Systems (exclusive of filters) that are not (1) packaged by AMSOIL or an authorized AMSOIL packager, and (2) sold by AMSOIL or an authorized AMSOIL Dealer.
- AMSOIL By-Pass Systems that have been improperly installed, abused, damaged or used in mechanically deficient equipment. Examples of mechanically deficient equipment include flawed or defective equipment due to abnormal operation, negligence, abuse, previous damage or improper modification, including use of components other than those from AMSOIL or AMSOIL aftermarket partners.
- Failure of equipment when the wrong filters are used or the correct filters are used beyond the service life recommended in writing by AMSOIL INC. or the original equipment manufacturer ("OEM"). The Consumer is solely responsible for determining a product's merchantability or fitness ("suitability") for a particular purpose and assumes all risks and liabilities when used other than in strict accordance with the written recommendations of AMSOIL.
- Failure due to a pre-existing condition or OEM defect unrelated to the use of AMSOIL By-Pass System.
- Repair or replacement of equipment because of normal wear.
- AMSOIL By-Pass Systems used in any manned aircraft or aviation application.
- AMSOIL By-Pass Systems that have been used in modified engines or for the purpose of racing.
- AMSOIL By-Pass Systems that have not been properly maintained according to written AMSOIL guidelines for maintenance requirements and filter change guidelines. Annual inspections of the fittings and hoses to check for loose connections, leaks, hose deterioration and cuts are required.
- AMSOIL By-Pass Systems which have been transferred. This warranty applies only to the By-Pass System in the vehicle in which it was originally installed.
- Damages if the Consumer does not send or make the parts requested available for inspection by AMSOIL or its insurer.

### WHAT AMSOIL WILL DO TO CORRECT A COVERED DEFECT:

If the AMSOIL By-Pass System is defective in materials, design and workmanship, AMSOIL will (1) replace the By-Pass System or defective component of the By-Pass System or issue a credit to the Consumer's account for the price paid by the Consumer for the By-Pass System; and (2) at the option and cost of AMSOIL, repair or replace components to the extent the damage was solely attributable to a defect in the AMSOIL By-Pass System. REPAIR OR REPLACEMENT, AS PROVIDED IN THIS PARAGRAPH, IS THE CONSUMER'S SOLE AND EXCLUSIVE REMEDY UNDER THIS LIMITED WARRANTY.

### WHAT AMSOIL WILL DO TO CORRECT A COVERED DEFECT:

- The By-Pass System and filter(s) are required to be returned.
- If there is engine damage and the vehicle is under warranty, file a claim with the OEM and notify AMSOIL at (715) 399-8324 immediately. In the alternative, you may mail a claim notice, along with the OEM denial to AMSOIL INC., ATTN: Technical Services, 1 AMSOIL Center, Superior, WI 54880, postmarked within 30 days of failure or alleged defect.
- Keep the filter(s) and failed parts for inspection by AMSOIL unless given to the OEM. You must allow the AMSOIL Technical Services Department to examine the By-Pass System and filters and, if necessary, the engine or equipment to determine the extent of damage and whether it was caused by a defective By-Pass System.
- Mail, at your expense, the following items to AMSOIL INC., ATTN: Technical Services, 1 AMSOIL Center, Superior, WI 54880:

- The By-Pass System and filters in their original, undamaged condition.
- Documentation describing the make, model and year of equipment, total accumulated miles and/or hours and duty cycle or service environment.
- Equipment or vehicle maintenance history documentation, including, but not limited to, date and miles or hours at the time of installation of the By-Pass System and installation and/or change of filters; periodic maintenance and inspection of the By-Pass System; and general equipment repairs made.
- Proof of purchase for AMSOIL By-Pass System (if available).
- Batch number from By-Pass System box or container (if available).
- The OEM warranty denial, if applicable, and claim notice (if not previously provided).

If your claim is approved, you will be reimbursed this mailing expense.

**AFTER A CLAIM IS FILED:**

- You must cooperate with the AMSOIL investigation of the claim and provide the information reasonably requested by AMSOIL.
- If your claim is paid by AMSOIL or its insurer, an attempt may be made by AMSOIL to recover those amounts from the OEM. If this occurs, you may be asked to provide further information pertaining to the failure and must cooperate with AMSOIL or its insurer in the recovery process.

**LIMITATION OF LIABILITY:**

THE LIABILITY OF AMSOIL ARISING OUT OF THE MANUFACTURE, SALE, DELIVERY, INSTALLATION, TECHNICAL DIRECTIONS OR RECOMMENDATION OF ANY AMSOIL BY-PASS SYSTEM, WHETHER IN CONTRACT, TORT, WARRANTY OR OTHERWISE, SHALL NOT EXCEED THE VALUE OF THE COMPONENT DAMAGED AS A DIRECT RESULT OF THE BY-PASS SYSTEM. IN NO CASE SHALL AMSOIL BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING, BUT NOT LIMITED TO, DAMAGE OR LOSS OF OTHER PROPERTY OR EQUIPMENT, LOSS OF PROFITS OR REVENUE, COST OF CAPITAL, BUSINESS INTERRUPTION, LODGING, TOWING OR COST OF REPLACEMENT EQUIPMENT. THE REMEDIES TO THE CONSUMER HEREIN ARE THE SOLE AND EXCLUSIVE REMEDIES. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. ALL IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO ANY WARRANTY OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE, ARE STRICTLY LIMITED TO THE DURATION OF THE EXPRESS WARRANTY APPLICABLE TO THE PRODUCT AS STATED ABOVE. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

**STATE LAWS AFFECTING THIS WARRANTY:**

This warranty shall be governed, interpreted and construed by, and in accordance with, the laws of the State of Wisconsin in the United States of America. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.
